

Wiz I commit my Body to the Duft to be decenter - by intered at my Decease: And as to the Disposition of such worldy Estate as it hath pleased the almighty to bestow rapan me, I do give & diffrage thereof in manner & form following. Imprimis, after all my fuft Debts are paid, I do give & begreath unto my beloved the Right, Vitte, & Intireft of mour have, or ever had unto thirteen acres of woodland which left belonged unto my still a policy of woodland which left belonged unto my Sifter Rebecca Coch of Eafthampton And al thirteen acres of woodland which I now own as my Property in the Town of Eafthampton afore for one of my Beds I give unto my Confin Elihu Rierfon together with the Beding belonging thereunto: and all the reft of my personal Estate, (escept forty Shillings which I give unto my Confin Hannah Darfons), I give & bequeath unto my Confin Abigail Divison, & to her Kirs, & assigns forever. Laftly I do hereby appoint my loving steel Rebecca Riefon vole Executor of this my last will, & Testament. In Testimony hereof & I have hereunto set my Hand, Heleal, this ninth pay of Janu ary, in the year of our Lord, one thou fand eight hundred and Jeven. 1807. Hannah Difborn mark.
